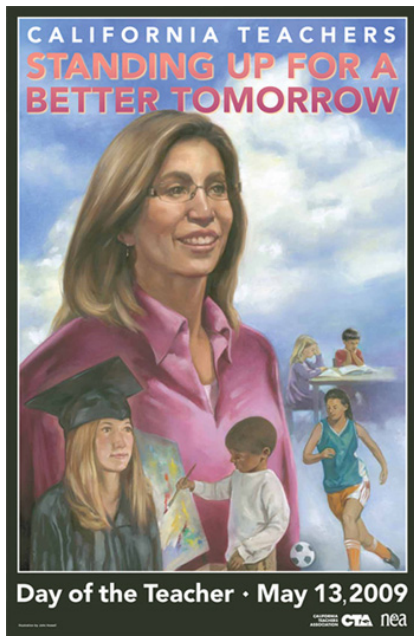

This theme was selected to emphasize the need to stand up for schools, teachers and students in the face of severe budget cuts. More than 27,000 educators have received layoff notices so far this year. The problem will only get worse if funds are cut further. That's why on this Day of the Teacher please Stand Up for a Better Tomorrow!

You Are Eligible for Automatic Insurance Protection

As a CTA/NEA member you are **automatically** eligible for **two** valuable insurance programs at **no additional cost**, the *CTA Death & Dismemberment Plan* and the *NEA DUES-TAB*. These plans are a **no-cost** insurance protection exclusively for CTA/NEA members. The CTA Death & Dismemberment Plan and the NEA DUES-TAB automatically cover you on September 1, following the date you become an eligible member, but even if you have just one year of credited membership, you will be eligible to receive a benefit. You may name anyone as your designated beneficiary. Simply complete one beneficiary registration form for CTA and one for NEA. By doing so, you will not only ensure that your designated beneficiary is registered, you will have personal security that comes with your CTA membership.

The CTA Death & Dismemberment Plan is designed to provide a life insurance benefit that **increases** with each year of continuous CTA membership, until the maximum benefit is reached after ten (10) years. The NEA DUES-TAB maximum benefit is reached after five (5) years.
