Involve Yourself in Facilities Planning and Development

The Contract specifies that Class Size Reduction/Facilities Planning Committees must be formed by the 20th day of school. The following is the contract language.

- a. The principal at each participating site will create a CSR and Facilities Planning committee by the twentieth (20th) working day of the school year.
 - (1) Each committee will meet at least four (4) times a year.
 - (2) Each committee will include, but not be limited to, the principal, a teacher from each grade level elected by Bargaining Unit members at that site, classified personnel, parents, and support staff.
 - (3) Each committee will elect its own chairperson(s).
- b. Each committee will make recommendations to the principal regarding the following aspects of CSR:
 - (1) Facilities Planning
 - (2) Grade level implementation for CSR
 - (3) Training for CSR
 - (4) Timelines for implementation and Facilities
 - (5) Short and long term goals for the site CSR and Facilities
 - (6) Other issues as determined by the committee.
- c. The principal will present the CSR Plan to the committee prior to submitting the plan to the District.

Tell Me More About Adjunct Duties

Adjunct duties is a term identified specifically with Stull Bill evaluation requirements. During your Stull Bill year, you are contracted to complete two non-instructional duties which would normally be performed before or after the Board Day. You pick your adjunct duties from a list provided by the site principal. The list would typically include

- Committee Work
- Dance/Athletic Events
- Leadership Camp
- Building Rep for the Montebello Teachers Association
- PTA Activities
- Special Site Events
- Office Bulletin Boards

Adjunct duties are not required during non-Stull years.

Who Gets Stulled?

- TC and Probationary Bargain Unit members are Stulled every year.
- Permanent Bargaining Unit members are Stulled every other year.
- Permanent Bargaining Unit members who have completed 10 consecutive years experience in this District and have not been referred to PAR in the past two years are Stulled every 5 years. Staff Restrooms To Be Serviced Daily

The Contract states that staff restrooms shall be maintained and adequately supplied on a daily basis. (Safety, Security, and General Working Conditions Section D.8.) Concerns regarding restroom facilities should initially be directed to the site principal.
