



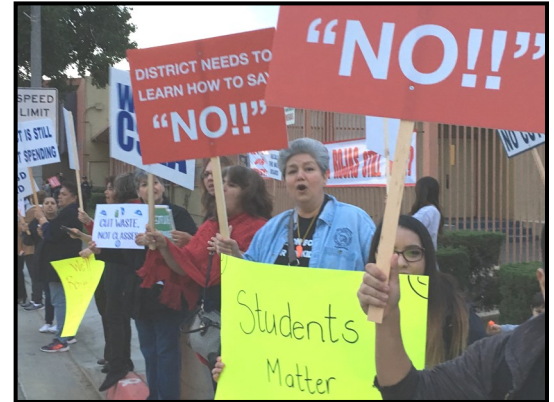

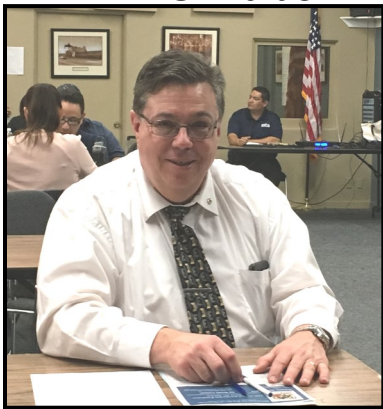

We Say “No” to Lay-Offs

Employees, students, and community members gathered together Thursday, February 16 to protest the Board of Education’s plan to lay-off employees. Members of the Board of Education acted 4 to 1 (Hector Chacon voted “no”) to send notices to 113 temporary contract and 156 probationary and permanent bargaining unit members.



CBO Ruben Rojas Misinforms on LCAP



Ryan Rice (ATC) is both the Revenue and Expense Committee MTA Chairperson and on the LCAP Advisory Committee.

Ryan discussed the Local Control Funding Formula (LCFF) and the Local Control Accountability Plan (LCAP) at the Revenue and Expense Open Hearing Tuesday, February 21. LCAP expenses are NOT causing the lay-off. **In fact, the LCAP calls for qualitative and quantitative improvements in education for our students.** Classroom expenses are a priority. Both the Revenue and Expense Committee and the LCAP Advisory Committee will continue to fight for the proper implementation of the District’s increased funding.

New Procedures for Renewing Your Credential On-Line

The CTC Online log on procedures for EDUCATORS changed on Thursday, February 16!

Educators logging on to CTC online will be required to create a user name and password. They will use that new log on instead of the SSN and DOB from that point on. This should be an easy process for educators to follow as it is set up to be as automated as possible. Instructions will also be posted on the web site.
