Bargaining Team Proposes Class Size and Case Load Caps

On October 21 the MTA Bargaining Team proposed ongoing class size and case load caps in order to permanently reduce student contacts and improve educational resources throughout the District. The next meeting with the District is Thursday, November 4. The MTA Team plans to submit a Wage proposal including a cost of living adjustment.
